- In the event of a dispute or disagreement in respect of the parties' agreement, the parties must use their best endeavors to reach an amicable settlement in the best interests of the cat.
- In no circumstances shall the FCCQ Inc. be bound to assist the parties in resolving any dispute or disagreement.
- This lease may be terminated in the event of:
 - any breach of the Rules of Code of Ethics of FCCQ INC
 - any breach of any applicable law, by-law or regulation in relation to the cat or
 - any breach of the terms and conditions or
 - any other conduct which is seriously prejudicial to the cat's welfare
- The **ORIGINAL** certificate of registration must be returned to FCCQ Inc upon the expiration or termination of the lease together with the relevant fee, see below.
